BACKGROUND INFORMATION

The evaluation is part of the programme 2017-2021 of the BRC-FL International Cooperation department financed by the Belgian Development Cooperation (DGD). The evaluation is focusing on the relevance, effectiveness, contribution, efficacy and sustainability of the First Aid (FA) program in Zimbabwe.

SUMMARY OF MANAGEMENT RESPONSE

BRC-Fl and ZRCS agree fully with the recommendations of the consultant. The recommendations given are general good practices that are already being implemented partially or fully by ZRCS, but more efforts will be needed to institutionalize sustainability. Therefore, it is good to see them listed here and to reflect on the way forward. The action points in the management response focus on strengthening the initiatives already taken. Although there will be no follow up project in Zimbabwe, we are confident that the developed action points will be put in good practice because they have already been acknowledged by the implementing partner which is ZRCS.

☐ Accepted	In Zimbabwe there is a shortage of First Aid trainers. ZRCS has trained 160 volunteers in Proficiency in First Aid in Q2 2022. Out of these 160 volunteers, 56 new FA trainers will be trained to balance out on the targeted training quotas. There is still a lack of trainers in rural areas. Zimbabwe is a big country, so it is important that each province has enough trainers available to cover their training need.
